



CALL FOR APPLICATIONS FOR ERASMUS+ MOBILITY IN FRANCE

Program Introduction

As part of the Erasmus+ Student and Staff Mobility Program supported by external action funds (AC171-HED), Lumière University Lyon 2, in cooperation with the Royal University of Law and Economics, is **launching a call for applications for a 6-month study stay in France** for undergraduate students in Law and/or Economics who wish to deepen their knowledge in the stimulating environment of University Lumière Lyon 2.

Although this mobility does not lead to a degree from University Lumière Lyon 2, it offers students the opportunity to complement their studies in Law and/or Economics and gain international experience.

Number of available places:

- 2 places for the Law program
- 2 places for the Economics and Management program

Each mobility lasts for 6 months.

Planned mobility dates: September 2025 - February 2026.

The application dossier must include:

- Transcripts for the current academic year and the previous year, if applicable
- A motivation letter in French or English
- A Curriculum Vitae
- A copy of the passport and/or identity card
- A certificate of enrollment (or equivalent) confirming registration at the home university
- A pre-selection of the desired courses
- A letter of recommendation (Optional)
- **Annex 1 – FO Form**, to be provided by candidates requesting an inclusion supplement

Evaluation Criteria:

- Academic prerequisites (30%)
- Quality of the personal project (30%)
- Assessment of the candidate's motivation during the interview with the selection committee (30%)
- Proficiency in the language of instruction (10%)

Composition of the Jury:

- Representative from each relevant department of RULE
- Representative from each relevant department of ULL2
- Representative from the International Relations Department of ULL2

Selection Procedure and Calendar:

1. Publication of the Call for Applications: April 23, 2025 – May 3, 2025
2. Deadline for submitting applications: May 9, 2025
3. Evaluation of applications: until May 16, 2025
4. Selection of applications – Ranking of candidates: May 20, 2025
5. Interviews with candidates who scored the highest in the ranking: May 21, 2025 – May 30, 2025
6. Publication of results: June 1, 2025*
7. Start of mobility: September 2025

**Appeal against the decision: candidates have a period of seven (7) days, starting from the date of publication of the results, to submit an appeal.*



Financial Conditions:

As part of this project, selected students will receive an **Erasmus+ KA171 scholarship** of **€900 per full month, capped at 6 months**, for a total maximum amount of €5,400.

An additional flat-rate allowance of **€1,735** is provided to cover **travel expenses** between Cambodia and France. The scholarship will be disbursed according to the following terms:

- **70% upon arrival in France,**
- **30% at the end of the stay,** subject to the **presentation of the required documents** (attendance certificate, mobility report, etc.).

Housing Conditions:

No accommodation is provided by University Lumière Lyon 2. Selected students will need to arrange their housing independently. They will receive support from the International Student Office, just like all incoming international students.

⚠ It is strongly recommended to research the cost of housing in Lyon in advance, as it can be high, as well as the cost of daily living.

An international student guide, containing all practical information to facilitate arrival and settlement, will be provided by University Lumière Lyon 2. An informational meeting will also be organized by the International Relations Department.

Inclusion Support

Students with **fewer opportunities** may be eligible for an **additional amount of €250 per month** (individual Erasmus+ support), **provided** they meet one or more of the criteria defined.

Candidates wishing to apply for this support must **complete the dedicated form** (Annex 1 – FO Form) and include it in their application dossier.

At the end of the selection process, preselected candidates must submit the required supporting documents to their international relations office, which will verify their eligibility for this support.
